

### **Transitioning Placements**

Year 6 and Year 11



If your child/ young person is in year 6 or Year 11, and has an EHCP, you should have expressed preferences for Year 7 or Post 16 settings/provision by now. If you have not done this please contact the SEN team on **01274 435750** (select option 1) and one of the admin team will be able to advise you.

# The process for transitioning placements (EYFS, Primary, Secondary and Post 16)

### Summer term in EYFS, Year 5 or Year 10

Current EYFS, year 5 and year 10, young people will require a transition review in the summer term where preferences are gathered regarding placements for Primary school, Year 7 and Post 16 placements for September the following year. By the end of June, families should have received a letter requesting their preferences for Primary, Secondary and Post 16.

### Autumn Term of Year 6 and Year 11

**September/October:** You are required to express preferences and completed Annual Review documents by:

- Friday 18th September requests for Specialist Provision (including Resourced Provisions)
- Friday 24th October request for mainstream provisions

**November/December**: The Local Authority considers the parental preferences, needs and the nearest available schools.

In cases where there is a proposed change of provision (mainstream/specialist), the Local Authority reviews the documentation received for the year 5 annual review.

Consultations with secondary school provision is undertaken.

### Spring term of Year 6 and Year 11

Primary and Year 7 placements will be announced by *February 15th* Post 16 placements will be announced by *March 31st* 

## Summer term for Year 6

Year 6 Annual Reviews are held with a representative from the named secondary school to review and monitor the transition process.

# Appeals about the Named School



### or that there is no School (or College/Setting) named in Section I of an EHC Plan

We would recommend you also appeal the contents of the EHC plan, as your child's needs and required provision are relevant in every appeal about the school/setting named.

Firstly, it's important to fully understand why the local authority reached this decision. It's always a good idea to continue talking to the local authority about your concerns or any questions you have.

You have **8 weeks** from the date on the letter to appeal the named school on the final plan. You do not need to consider mediation if you are only appealing the named school on the plan but you must if you are also appealing the contents the plan alongside the named school. If you are appealing both the contents and the school named you must first contact Collis Mediation and consider mediation first before lodging the appeal. The decision may be overturned at mediation and can be a faster way to achieve your outcome although in some cases the Local Authority decide to uphold their decision. If this happens you still have the right to appeal to the SEND tribunal.

If you are **appealing the contents of the plan alongside the named setting/school** you will need to consider mediation first. Please contact Collis mediation via their website and fill in the online form: <u>https://www.collismediationltd.com/mediation/send-mediation</u>

If you decide to go ahead with mediation, Collis will arrange this for you. If you decide not to go ahead with mediation, you can collect your mediation certificate and send off your appeal form to the tribunal service.

If you are **only appealing the named school** on the final plan, you can start completing the appeal application form 'SEND Appeal Form 35'

### Legal Aid

At SENDIASS we advise all our families who are lodging an appeal to check if they are eligible for Legal aid. There is no fee to lodge an appeal at SEND Tribunal. Although you may wish to seek legal advice from a solicitor which would incur fees. You may want to check if you are eligible for legal aid through this link:

If eligible, you may then receive advice from a solicitor who can advise you on your case. The Solicitor might not represent you at the final hearing but they may help you to build a case and prepare you for the hearing.
